SUCCESS STORY

Following a stroke that led to the loss of the consumer's nursing career and housing, a consumer was exploited by financial fraud upon receiving social security benefits. She appointed an Organizer as her representative payee but later sought to terminate the arrangement due to late payments and accumulated late fees. A meeting was arranged, resulting in the representative payee's agreement to relinquish their role. However, the representative regained control of her finances after falsely reporting her as homeless and financially incompetent to Adult Protective Services (APS). With the consumer's authorization, I contacted APS and confirmed no record of the consumer in their database. Despite nearly giving up, the consumer and I persevered, ultimately achieving victory in her three year battle with Organizer and Social Security Administration to self-manage her benefits.

National Disability Employment Awareness Month (NDEAM 2024)

San Diego, California - October 1, 2024 - Access to Independence announces it is joining the U.S. Department of Labor's Office of Disability Employment Policy in recognizing National Disability Employment Awareness Month, an annual awareness campaign that takes place each October. The purpose of National Disability Employment Awareness Month is to educate about disability employment issues and celebrate the many and varied contributions of America's workers with disabilities. This year's theme is "Access to Good Jobs for All."

The history of NDEAM traces back to 1945, when it started as a week and focused only on people with physical disabilities. Later, it expanded to a full month, and its name and scope evolved to acknowledge the importance of increasing the workforce inclusion of people with all nature of disabilities.

"Our communities and economy are strengthened by the inclusion of all people, including people with disabilities," said Assistant Secretary of Labor for Disability Employment Policy Taryn M. Williams. "Their contributions have historically been vital to our nation's success and are more important today than ever. We must build an accessible, equitable economy that fully includes the talent and drive of those with disabilities."

Reflecting this year's theme, throughout the month, Access to Independence will be engaging in a variety of activities to educate its our community on disability employment issues and its commitment to an accessible and equitable work culture. These efforts include participating in the NDEAM job fair.
